For non-emergency personnel

Methods and materials for containment and cleaning up

Small spill

Contain and collect spillage with non-combustible, absorbent material e.g. sand, earth, vermiculite or diatomaceous earth and place in container for disposal according to local regulations (see Section 13). Store in accordance with local regulations.
