SECTION 4: First aid measures

4.1 Description of first aid measures

Eye contact

Ingestion

Can enter lungs and cause damage. Do not induce vomiting. If vomiting occurs, the head should be kept low so that vomit does not enter the lungs. 8.2 Exposure controls

Appropriate engineering controls
