SECTION 4: First aid measures

4.1 Description of first aid measures

Eye contact : Get medical attention immediately. Immediately flush eyes with plenty of water, occasionally lifting the upper and lower eyelids. Check for and remove any contact lenses. Chemical burns must be treated promptly by a physician.

Inhalation : Get medical attention immediately. Remove victim to fresh air and keep at rest in a position comfortable for breathing. It may be dangerous to the person providing aid to give mouth-to-mouth resuscitation.

If material has been swallowed and the exposed person is conscious, give small quantities of water to drink. Do not induce vomiting unless directed to do so by medical personnel. 5.3 Advice for firefighters
